

# THE NEW HAMPSHIRE LOTTERY COMMISSION® 7-11-21® LIVE! LIVESTREAM EVENT RULES

The **New Hampshire Lottery Commission** (Commission) 7-11-21® Live Streaming Event Promotion ("the Live Streaming Event") begins on Sunday, July 11, 2021 at 7:11PM Eastern Time (ET) and will end on Sunday, July 11, 2021 at 7:32PM ET ("the Drawing Entry Period").

One (1) Drawing will be conducted at the conclusion of the Drawing Entry Period to select six (6) winners from qualified entries. **Six (6)** winners will be selected to receive the cash prize, the amount of which will be determined during the Live Streaming Event. The Live Streaming Event is held via a live video broadcast on the **Facebook** platform ("the Platform") and the winner is contacted after the Drawing, via the Platform, to confirm eligibility.

# **ENTRY RULES:**

- 1. No purchase necessary to enter or win.
- 2. All entries must be submitted within the Drawing Entry Period for the Drawing.
- 3. Winners will be randomly selected from the following method of entry:
  - Users are entered into the Drawing by commenting in the chat window of the Facebook Live broadcast with their favorite or 'lucky' number during the specified Drawing Entry Period.
  - The comment in the chat window must contain a number in either numeric or written form, i.e., ten or 10, to constitute a qualified entry, and deemed, by the Commission, as adhering to the Commission's social media policy.
- 4. Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Live Streaming Event and may result in permanent blocking from the Commission's Facebook page.
- 5. Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.
- 6. Entries that do not contain a number in either numeric or written form will be disqualified.
- 7. The Drawing is open to all who are at least eighteen (18) years old or older.
- 8. No person may win more than one (1) prize per event.
- 9. Entrants are subject to all Commission Rules and Regulations, drawing procedures and Facebook rules and regulations.
- 10. This Live Streaming Event and/or any parts thereof, including the award of any prizes, is void where prohibited by law.
- 11. Employees of the Commission, Scientific Games Corporation and MDI Entertainment, LLC are prohibited from participating in this Live Streaming Event.

### **PRIZES:**

- 1. Odds of winning depend on the number of entries received for the Drawing.
- 2. Prizewinners will each receive a Cash Prize, the value of which is determined during the live event.

4. Upon conclusion of the Drawing Entry Period, six (6) entrants will be randomly selected to win the cash prize, the amount of which will be determined during the Live Streaming Event.

#### **WINNER NOTIFICATION:**

- 1. After the drawing is conducted and verified, eligible winners will be announced and tagged in a Facebook post on the Commission's page.
- 2. Winners must private message the Commission on Facebook from the winning account in order to confirm their standing as a selected winner.
- 3. By participating in the Contest, each Prizewinner agrees all decisions regarding the Contest and Live Event are within the sole and exclusive discretion of SGI and are final and binding on all Prizewinners.

## **PRIZE CLAIMING:**

- 1. To claim a prize, each winner shall complete a Commission Prize Claim Form and return with proper identification within 30 days of the forms being mailed from the Commission. Failure to comply will result in the cash prize being forfeited.
- 2. Once the Commission Prize Claim Form is received by the Commission, the winner's information will be sent to SGI to start the prize fulfillment process.
- 3. If an entrant responds to the Commission's notification within the specified deadline but fails to provide a valid email address, phone number and acceptable form of identification to the Commission they may be disqualified and the prize will be awarded to an alternate.
- 4. The Commission offers no warrantees or guarantees of product quality and that availability and quality of the prize and its conformance to advertised representations is the sole responsibility of the promotional partner.
- 5. The Commission shall not be responsible for any prizes lost, damaged or stolen during shipment, pickup or use.
- 6. The Commission shall not be responsible for injury or loss of life resulting from any prize awarded.
- 7. Participants release and hold harmless the Commission and its agents and employees from any liability arising out of participation in the drawings. The Commission is not responsible for any negligence of any person, or any claim, liability, injury, property loss, or other loss to participants or their companions arising from or in connection with any event or occurrence related to these drawings.
- 8. The Commission, at its sole discretion, may disqualify an entry, winner, or designee from participating in any aspect of the drawing if they deem or suspect that such person has engaged in or has attempted to engage in any of the following:
  - a. Act in violation of Facebook Platform Policies;

  - d. Behave in any unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent, potentially fraudulent, or unusual behavior or activity; or
  - **e.** Participate in any activity deemed to be generally inconsistent with the intended operation of the drawing. The Commission reserves the right to prosecute and seek damages from any such individual to the fullest extent of the law.

- 3. The Commission reserves the right to cancel or modify the Live Streaming Event if it becomes technically or otherwise corrupted.

The Commission reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Live Streaming Event; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Live Streaming Event; or to be otherwise acting in an unsportsmanlike manner.
- 5. The Live Streaming Event is not sponsored, endorsed, administered by, or associated with Facebook.

# **CHILD SUPPORT INTERCEPT:**

Pursuant to RSA 284:21-v, the Commission is required to review all lottery prize claims subject to federal tax reporting with a child support database provided by the Department of Health and Human Services (DHHS). In the event that a winner of any prize package described above owes child support, the winner shall have up to 21 days from the draw date to settle the total arrearage due as determined by DHHS to the DHHS, after which settlement the winner will be awarded the prize. Failure to settle any arrearage shall result in that winner's prize package being forfeit and the package will be issued to the first available alternate winner. The original winner(s) owing Child Support shall receive no other prize or compensation from the Commission relating to this game.
