

# GO PATS! SECOND CHANCE DRAWING

## Official Rules

**Promotion Name: Go Pats! Second Chance Drawing**

### OFFICIAL RULES

- From **Monday, August 29, 2022 at 12:00:00AM – Monday, June 5, 2023 at 11:59:59PM** (the "Promotional Period"), any non-winning and active (subject to change) qualifying \$5 Go Pats! (#1572) scratch ticket may be used to enter the **Go Pats! Second Chance Drawing** ("Promotion").
  - Ticket(s) that are eligible for entry are subject to change at the discretion of the New Hampshire Lottery.
- For every non-winning game ticket(s) a player submits, the player will be awarded 1 entry into the drawing. The non-winning eligible ticket and the resulting entries awarded are 1 ticket: 1 entry.
  - For example, a \$5 non-winning Go Pats! (#1572) scratch ticket, will equal one (1) entry.
- Entry is limited to twenty-five (25) total tickets per person per day (24-hour period).
  - For example, a \$5 non-winning Go Pats! (#1572) scratch ticket will count as one (1) of the twenty-five (25) total entries.
- A player does not need to retain the game ticket(s) submitted as proof of eligibility to claim their prize if selected as a winner.
- Entries are good for one drawing only. For example, tickets entered for the first drawing are not eligible to win in subsequent drawings.
- Three (3) drawings will be conducted. From all eligible players, the prizes will be awarded as follows:

## GO PATS! SECOND CHANCE DRAWING

- The final verified drawing results will be posted to the website and the mobile app, on (or around) a week after the drawing has occurred.

To be eligible, a player must have a My603Rewards account via the NH Lottery mobile app. Tickets must be entered online through their My603Rewards account on the NH Lottery mobile app, which is located in both the Apple and Android application stores. Deadline for entry is **Monday, June 5, 2023** to participate in the drawing.

Existing My603Rewards or New Hampshire iLottery account holders can log in through the mobile application. New participants must register for a My603Rewards or login using their New Hampshire iLottery account credentials through the mobile application. By successfully transmitting a completed online entry on the mobile app with the appropriate information as directed underneath the Go Pats! Second Chance Drawing screen, each participant or each eligible ticket will be entered into the Promotion.

Entries of game ticket serial numbers determined to be in an expired, stolen or not part of a valid sold or promotional inventory status are not eligible.

All information submitted online by entrants is subject to, and will be treated in a manner consistent with, the New Hampshire Lottery Commission's (hereinafter, "the Lottery") Privacy Policy, which is currently accessible at: <https://www.nhlottery.com/Privacy-Policy>. ### RANDOM NUMBER GENERATOR DRAWING AND RESULTS:

The actual drawing date will be determined by the Lottery personnel, at the direction of the Executive Director, and the final, verified drawing results will be posted to the mobile application on (or around) **a week following the completion of the third and final drawing**. The prize winners will be randomly selected from among all eligible entries received. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will be declared the official winners of this Promotion. There will be three (3) drawings with the following prizes:

    - NOTE: The Twenty-five (25) winners from Drawing #1 will attend a 2022 Season home game and the seventy-five (75) winners from Drawing #2 and #3 will attend a 2023 Season home game.

- One (1) General Admission Parking Pass.

Prizes sent to winners from the Lottery will be through a digital platform. **Tickets to all events at Gillette Stadium will be mobile tickets.** Winners can utilize their mobile tickets via the Gillette Stadium App, which is available on the App Store and Google Play.

To claim a prize, each winner shall complete a Commission Prize Claim Form and return same within thirty (30) days of the forms being mailed from the Lottery. Failure to comply will result in the prize package being forfeited and the prize will be awarded to the first available alternate winner.

Deadline to enter tickets for **Drawing #3 is Monday, June 5, 2023 at 11:59 PM**

#### What are the prizes for the Go Pats! Second Chance Drawing Promotion?

- **Season Tickets Home Game Package (5 Winners Total):**

#### Which tickets are eligible for the Go Pats! Second Chance Drawing Promotion?

From **Monday, August 29, 2022 at 12:00:00AM and ends on Monday, June 5, 2023 at 11:59:59 PM.** (the "Promotional Period"), any non-winning and active (subject to change) qualifying \$5 Go Pats! (#1572) scratch ticket may be used to enter the **Go Pats! Second Chance Drawing** ("Promotion").

#### How do I know if my ticket is eligible?

If you have a non-winning \$5 Go Pats! (#1572) scratch ticket that is active (meaning it is still eligible for cashing at retail) that ticket is eligible for entry. Otherwise, a message will appear once a ticket is scanned on the app saying whether or not it is eligible.

**Am I responsible for any taxes on these prizes?**

Federal taxes estimated at 24% of the value of each package that is valued at \$600 or greater will be borne by the Commission. The Lottery Commission's vendor, SG or MDI will send winners IRS Forms 1099 in January of the year following the respective usage of the awarded prize. Any other taxes or fees will be responsibility of the prize winners.

**Can I enter the drawing more than one time?**

Yes! Registered My603Rewards users will receive **one (1) entry for each ticket of an eligible non-winning \$5 Go Pats! (#1572) scratch ticket scanned.**

Maximum 25 total tickets per day. Meaning a player may only enter 25 \$5 Go Pats! (#1572) scratch tickets regardless of dollar value.

An entrant may only win one (1) prize.

**Do I need to keep my tickets after submitting them into the drawings?**

No, you are not required to keep your tickets.

**Can I mail in my entries?**

No, only entries via the NH Lottery mobile app are allowed.
